 - 申請專利者，核章後的申請書務必影印留存，連同「專利申請揭露書」繳交產學處智財技轉中心。
 - 每次申請紙本論文延後公開至多為5年，且需逐次申請；第2次起之申請程序，仍應取得原所有學位考試委員審核確認，或經原就讀系所之系(所)務等會議審核確認。
- Please provide two original copies each of the application form and the certification document. After completing all required signatures, submit one set along with the printed thesis to the department office, and the other set to the library during the school-leaving process. Incomplete documents will not be accepted.
 - It is recommended to discuss the embargo period for the electronic thesis/dissertation: on-campus (0-10 years), off-campus, including ND LTD system (0-99 years).
 - Patent applicants must keep a copy of the signed form and submit it with the Patent Disclosure Form to the Intellectual Property and Technology Transfer Center.
 - Each embargo period shall not exceed five (5) years from the date of application. From the second application onward, approval must be reconfirmed by all original degree examination committee members or by the departmental (or institute) affairs meeting of the applicant's original academic unit.
